Issues Addressed in Abila netFORUM Pro

2015.4

The following issues are addressed in Build 2015.4.

Accounting

Issue #	Description
18109	netFORUM Pro now allows a user to 'pay' for \$0 orders in order to create an invoice and close the invoice.
18251	A cancelled invoice now correctly retains a cancellation fee and refunds the balance to a credit card or records a credit on the individual's record.
18329	An invoice now shows the non-member price when a non-member purchases an item and pays the non-member price.
18551	Negative credits are no longer created.
18650	Negative amounts no longer appear on an individual's profile.
17962	A partial refund now refunds the credit card of an individual registered for event if the guest cancels or puts money as credit available on the individual's record.
11992	Making mass payments on multiple discounted orders no longer causes balances and credits on invoices.
11587	Installment payments made above the installment amount are now distributed properly.
18098	Amounts due on an invoice with multiple orders billed to an organization now show correct Balance Due after partial payment.
12481	Cancelling a registration with a discount applied using 'bill me' now correctly cancels the registration and the order.

18814	The tax amount on a membership is now included in the installment payments.
18864	Manual batches no longer result in auto batches.

Issue #	Description
10902	A 'NULL' value in an import workbook is now correctly imported as 'NULL Value' into the data field.

Certification

Issue #	Description
18142	Certification requirements added after a purchase are now saved without displaying an error message.

CRM

Issue #	Description
17875	Records are completely deleted and are no longer visible after the overnight process runs.
18634	Records uploaded and downloaded from NRDS now update correctly.
18635	Business Addresses now map correctly to the NRDS 'Office Street' address.

E-Commerce

Issue #	Description
18941	Items where a customer does not qualify for the member price are no longer added as \$0 to the shopping cart.

E-Marketing

Issue #	Description
18100	An image size changed in the HTML Editor now correctly remains re-sized when sent in an email.

Events

Issue #	Description
16314	Event integer demographics are now recorded as entered in any combination up to 10 digits in length.
18925	Event set-up and registration fees are no longer swapped among events.

eWeb

Issue #	Description
18191	Dependent memberships now correctly show listed when shopping as Guest for primary membership in eWeb.

Issue #	Description
18244	The online help topic 'How to Link Directly to a Product in the Online Store' now correctly describes the process for obtaining a product URL.
18492	The online help topic 'Modifying the Payment Date' now correctly describes the process for setting payment dates and batch dates in manual batches.
18651	The online help topic 'Importing a Prospect List' no longer directs users to use placeholder names.
19118	The online help topic 'Browser and Operating System Requirements' has been updated with the latest requirements.
